Participant Contract – Horse Trail Riding Expo 2019

Please read the following information carefully and call 402-440.2630 if you have any questions. HTRE refers to Horse Trail Riding Expo organizers, volunteers, presenters, and anyone related to the HTRE. Participant refers to any rider requesting to participate in this event.

Participation, Stalling, and Waste Removal Information

- ✓ Our presenters will be demonstrating to you and our audience how to achieve optimal use of your already trained horse. Unless otherwise noted, these sessions are not for new or green horses. Do not bring a horse that has behavioral issues, including, but not limited to, kicking, bucking or rearing, or if the horse is not use to crowds and other horses. We reserve the right to dismiss any horse from a demo if it is deemed unsafe for its owner or other riders.
- ✓ No stallions will be allowed to participate in this event. No exceptions.
- ✓ Do not bring additional horses to this event.
- ✓ Some of our demonstrations are progressive learning and we will require participants to attend all of the sessions. The number of sessions is noted on the Participant Agreement. Only register if you can attend all sessions
- Participants and their horses must be on premises 90 minutes prior to your assigned clinic or demonstration. Check in at the show office when you arrive. If you did not purchase a stall for the event, your horse must remain in or tied to your trailer until your scheduled event. All overnight horses must be in stalls.
- ✓ Horses stalled at the event may arrive Friday evening after 4:00 pm or Saturday morning. Your stall assignment will be given to you at the show office.
- ✓ Please note: There are no wash facilities at this venue so you will need to bring in a clean horse.
- ✓ Bring your own shavings and clean your own stall and around your trailer at the conclusion of the event. There will be a site for manure and used shavings.

Payment

- ✓ All Participants in clinics will be assigned on a 'first-received' basis according to the postmark and provided we deem suitable for the specific clinic. For example: We are looking for a variety of gaited breeds for the Anita Howe Clinic. Part of our selection will be based on your horse's breed.
- ✓ Every attempt will be made to assign the Participant to the clinic of their choice. Please read the requirements carefully to see if you and your horse will quality.
- ✓ All HTRE management decisions are final.
- A confirmation will be emailed to you when your registration and payment are received. If you do not receive this confirmation within 14 days of mailing your confirmation please contact Mary Hanson (402-423-8746.
- ✓ If you are not chosen to participate, your contract and check will be returned.

Rejection of Applicants and Exhibitors:

The HTRE reserves the right to reject any applicant for space at any time and reserves the right to regain possession of any space by refunding the applicant or exhibitor the amount paid for space.

Wristbands

- ✓ Your wristband will be given to you at the gate upon arriving and valid only on the day(s) you are participating in the event. Provide the gate attendant with your name as shown on the Participant Contract.
- ✓ The wristbands are only valid for the Participant. All helpers, family members, and friends must purchase a wristband each day attending.
- ✓ Forgotten, Lost or Stolen wristbands will not be replaced. You will be subject to the daily entry fee.
- ✓ No exceptions.

Assumption of Risks and Indemnification
